SIXTY PERCENT OF CLIENTS SUCCESSFULLY EXITED THE PROGRAM INTO PERMANENT HOUSING OR A CONTINUUM OF CARE. IN ADDITION TO CORE SERVICES, WE OFFERED COMPREHENSIVE PROGRAMMING, INCLUDING FINANCIAL LITERACY CLASSES, CHILDCARE, YOUTH ENRICHMENT ACTIVITIES, FITNESS AND PARENTING CLASSES, AND CAREER-BUILDING WORKSHOPS.
