SHELTER PROGRAM - THE STEPS TO INDEPENDENCE PROGRAM OFFERS SAFE, TEMPORARY SHELTER FOR FAMILIES WITH CHILDREN AND SINGLE WOMEN FOR APPROXIMATELY 90-120 DAYS WITHIN A STRUCTURED, TRAUMA-INFORMED ENVIRONMENT. RESIDENTS ARE PROVIDED PRIVATE FAMILY ROOMS, DAILY MEALS, AND ACCESS TO INTENSIVE WRAPAROUND SERVICES, INCLUDING CASE MANAGEMENT, FINANCIAL LITERACY EDUCATION, JOB READINESS TRAINING, PARENTING SUPPORT, BENEFITS NAVIGATION, AND HOUSING ASSISTANCE. THE PROGRAM IS DESIGNED TO STABILIZE FAMILIES IN CRISIS WHILE EQUIPPING THEM WITH THE TOOLS, RESOURCES, AND SUPPORT SYSTEMS NEEDED TO ACHIEVE LONG-TERM INDEPENDENCE AND SELF-SUFFICIENCY. EACH YEAR, THE PROGRAM SERVES APPROXIMATELY 50 FAMILIES AND 150 INDIVIDUALS.

PANTRY OF HOPE AND NEW BEGINNINGS BOUTIQUE - THE PANTRY OF HOPE PROVIDES CONSISTENT ACCESS TO NUTRITIOUS FOOD AND ESSENTIAL HOUSEHOLD ITEMS FOR BOTH SHELTER RESIDENTS AND COMMUNITY MEMBERS FACING FOOD INSECURITY AND FINANCIAL HARDSHIP. THROUGH WEEKLY FOOD DISTRIBUTIONS, FAMILIES RECEIVE GROCERIES AND CRITICAL SUPPORT THAT HELP REDUCE FINANCIAL STRAIN, IMPROVE HEALTH OUTCOMES, AND STRENGTHEN OVERALL HOUSEHOLD STABILITY. THE BOUTIQUE SUPPORTS INDIVIDUALS AND FAMILIES AS THEY PREPARE FOR EMPLOYMENT, SCHOOL, AND INDEPENDENT LIVING, HELPING RESTORE CONFIDENCE, DIGNITY, AND STABILITY DURING CRITICAL TRANSITION PERIODS.
